❖ Dashboard to reflect DTM status on or before 30 Jun 24

## Recipient

❖ A member in good standing of a club in good standing

## Period

❖ During the program year 2023-24

## Recognition

❖ Pin or Badge

## Criteria

- ❖ 4 Club Officers to attend the complete TLTP training as conducted by District (top up training is not considered) [Cycle 1]
- ❖ Submit Club Success Plan to Area Director by email on or before 31 Jul 23
- ❖ Complete club membership renewals by 15 Sep 23 (minimum 12 members) for Oct 23 to Mar 24 cycle
- ❖ Achieve 95% Pathways adoption by 15 Sep 23
- ❖ Achieve 3 DCP points by 15 Sep 23
- ❖ 5 Members to attend the Area Conference and Division Conference each [Cycle 1]

# Bulls Eye

## Criteria

❖ Add 2/3/5/7 New /Reinstated /Dual member to the club within a month

## Process

❖ Verification from Dashboard

## Recipient

❖ Vice President –Membership

## Period

❖ July 23 | Oct 23 | Nov 23 | Dec 23 | Jan 24 | Apr 24 | May 24 | Jun 24

## Recognition

❖ VPM – TI merchandise – Bronze/ Silver/ Gold/ Platinum

# POWER OF TWO RETURNS

## Criteria

- ❖ New /Reinstated /Dual member joining a club within the defined period and paying membership fees to TI till 30 Sep 24 on or before 31 Mar 24 in a single transaction

## Process

- ❖ VP Membership to submit this [form](#) on or before 15 Apr 24

## Recipient

- ❖ Joining Member
- ❖ Vice President –Membership (when 5 club members qualify for Power of Two Returns)

## Period

- ❖ Membership start date of between 1 Nov 23 and 28 Feb 24 and paid to TI on or before 31 Mar 24

## Recognition

- ❖ Joining Member - TI Merchandise
- ❖ VPM - Plaque



# RETENTION CHAMPS

## Criteria

❖ Club to renew 75% of membership base by 15 Sep 23 (only applicable to clubs with 20+ membership base as on 1 Jul 23)

## Process

❖ Verification from Dashboard

## Recipient

❖ Executive Committee Members who have completed their renewals by 15 Sep 23

## Period

❖ Jul to Sep 23

## Recognition

❖ TI Merchandise

# TORCH BEARER

## Criteria

- ❖ **Minimum 10 members of the club complete renewals for Oct 23-Mar 24 period by 31 July 23 and for Apr 24 – Sep 24 period by 31 Oct 23**

## Process

- ❖ **Verification from dashboard**

## Recipient

- ❖ **All members who complete both the annual renewal**
- ❖ **VPM (July to Dec)**

## Period

- ❖ **Program year 2023-24**

## Recognition

- ❖ **TI membership pin**
- ❖ **Plaque**

# EXPRESS CLUB

## Criteria

❖ Achieve 5 DCP points and have active membership exceeding the base membership (i.e. as on 1Jul 23) by at least one member by 10 Nov 23

# CORPORATE SPRINT

## Criteria

❖ A corporate club to have a minimum net growth of 10 members over base as on 31 Oct and maintain the net growth as on 30 Apr

# TRAILBLAZER

## Criteria

❖ Clubs with membership base between 8 and 12 (both included) as on 1 Jul 23 shows a net growth of 3 members by 10 Nov 23

## Criteria

## Criteria

## Period

- ❖ Program Year 2023-24

# FANTASTIC FOUR

## Criteria

- ❖ Four unique members of the club complete Level 1 in any path (home club should be chartered in program year 22-23 or 23-24)

## Process

# CHANGE MAKER

## Criteria

- ❖ Club that has been assigned and has an active sponsor/ mentor/ coach achieves Distinguished status

## Process

- ❖ Verification from Dashboard
- ❖ Confirmation from club President
- ❖ Confirmation from Club Growth Director

## Recipient

- ❖ Member serving as Sponsor, Mentor or Coach assigned during program year 22-23 or 23-24 and contributed to the club in achieving Distinguished status

## Period

- ❖ Program Year 2023-24

## Recognition

- ❖ Outstanding Toastmaster Pin

# GROWTH LEADER

## Criteria

- ❖ A Corporate or Institution or Rotary Toastmasters Club chartered through a member generated lead on or before 30 Apr 24

## Process

- ❖ Nomination by Division Director (before commencement of club charter process) to Club Growth Director office

## Recipient

- ❖ Any member (who is not a District officer and has also actively contributed towards charter of the lead)

## Period

- ❖ Program Year 2023-24

## Recognition

- ❖ Trophy +TI Merchandise

# HELPING HAND

## Criteria

- ❖ An active club to adopt a club that is less than 15 members (base membership as on 1 Jul 23 or as defined by Club Growth Director office from time to time) and help it become Distinguished by 30 Apr 24

## Process

- ❖ President of the active club to discuss the intent with Division Director and send an email request to Club Growth Director office expressing intent on or before 31 Dec 23

## Recipient

- ❖ Club
- ❖ Upto 5 members as nominated by Club President of the active club and confirmed by the adopted club

## Period

- ❖ Expression of intent to be placed and confirmed on or before 31 Dec 23
